Welcome to the ERAS-DOME!!

It's here at last! Web-based PDWS! Running at lightning speed with no issues at all. Oh, wait... That was just a dream I had last night!

Some tips to help with getting a handle on the new & improved ERAS:

- 1. Create your own filters! These will be invaluable for sorting your applicants.
- 2. When assigning an interview status, if you check the wrong status (i.e. you checked Invited to Interview instead of Waitlisted for Interview) you just need to click the edit button, uncheck the incorrect status and check the correct one.
- 3. You can assign more than 1 application status! For instance, you can check Application Reviewed and On Hold.
- 4. You can assign statuses in bulk. If I have a filter for USMLE scores lower than 200. When I run that filter I can select all of those applications by checking the box next to Applicant Name and then in the dropdown box in the lower right corner chose what status I want them to be.

This online program allows applicants to sign up for interviews themselves. You can set up e-mail templates, add attachments to your e-mails, set up interview dates and times and waitlist slots. You can even set up to allow your interviewers to sign up for days they are available. Very user friendly and fairly inexpensive. You will get a quote up front based on how many invites you plan send out. Actual bill is based on how many invites were sent.

TAGME Window Now Open! TAGME is a wonderful learning tool and resource for PCs. The Application dates are: September 1 - November 30: for monitored assessment sites between January 1 - June 30.

- Please visit the TAGME website http://www.tagme.org/ to learn about the only certification available to the Program Coordinators.
- "There are no study guides or textbooks to read. Knowledge of the day to day management of a residency training program is a major part of preparation for your certification.
- There are two separate and distinctly different parts of the TAGME certification process, the work effort assessment tool (WET) and the monitored assessment tool (MAT). The WET is designed to assess your knowledge of your residency training program and how it functions as well as your ability to find and access information relative to graduate medical education. The MAT is designed to assess your knowledge of the ACGME/AOA requirements for successful maintenance of a residency training program."
